REGULATIONS
on the Prize of the Federal State Autonomous Educational Institution of
Higher Education “Peoples’ Friendship University of Russia Named after Patrice
Lumumba” for Scientific Achievements and Contribution in the Field of
Mathematics

1.1 These Regulations determine the procedure and terms for awarding the Prize of the Federal State Autonomous Educational Institution of Higher Education “Peoples’ Friendship University of Russia named after Patrice Lumumba” for scientific achievements and contribution in the field of Mathematics (hereinafter referred to as the Prize, RUDN University).

1.2 The Prize is awarded for achievements in the development of fundamental mathematics and applied research in mathematics in the Russian Federation and in the world, including the contribution to achieving the UN Sustainable Development Goals¹.

1.3 The Prize is awarded once in three years to individual researchers or research teams of no more than three people (hereinafter referred to as the Applicants), regardless of their citizenship. The prize is not re-awarded².

1.4 The information about the Competition for the Prize (hereinafter referred to as the Competition) is posted on the official website of RUDN University.

1.5 The amount of monetary reward of the Prize is determined by the Managing Committee once every three years. In case a research team is nominated for the Prize, the total amount of the honorarium is divided among all members of the team in the ratio of 50% - to the head of the team, 50% - to the team members in equal shares. The decision to change the Prize honorarium shall be made by the Management Committee of RUDN University and approved by Order of RUDN University before the date of the announcement of the current year’s competition.

1.6 An integral part of the Prize is the badge and the badge certificate. If a research team is nominated for the Prize, a certificate and a badge are awarded to each member of the research team.

1.7 These Regulations and amendments made to it are approved by the RUDN University Academic Board and put into effect by the Order of RUDN University.

2. Procedure for Conducting a Competition for the Prize

2.1 The current year's competition shall be announced in March of the year of the Competition by order of the first Vice-rector-Vice-rector for Scientific Work of RUDN University (hereinafter referred to as the Order). The award ceremony shall be held in August as part of the events of the International Conference on Differential and Functional Differential Equations (DFDE).

2.2 In the Order on the announcement of the Competition, initiated by the Director of Mathematical Institute named after S. M. Nikolskii, must be specified the following information:

2.2.1. start and end dates for submitting applications for the Prize, the procedure for submitting applications;

2.2.2. terms and procedure for posting the information about the Competition, Competition documentation, application forms and other necessary information on the RUDN University website;

2.2.3. departments and employees of RUDN University responsible for organizing and conducting the Competition (stages of the Competition) with their contact details indicated;

2.2.4. terms and procedure for summing up the Competition results.

2.3 The deadline for submitting Applications shall be no later than May of the current year. After the submission deadline has passed, the employee (department) responsible for collecting applications shall form a list of applications for consideration by the Competition Commission (hereinafter referred to as the Commission).

2.4 The Commission shall review the received applications and form a proposal (request) to approve the Competition winner within no more than 2 (two) months from the date of completing the submission of Applications.

2.5 The RUDN University Academic Board shall make a decision to award the Prize to the nominees - the Competition Winners based on the Commission's request no later than August 01 of the current year.

2.6 The decision of the RUDN University Academic Board to award the Prize shall be approved by the Order of RUDN University and posted on the official website of RUDN University (<https://www.rudn.ru/>).

2.7 The Order on Approving the Competition Winner shall indicate the following:

2.7.1. winner's last name, first name, patronymic name (if any), their position, academic degree, academic title (if any), citizenship, organization - primary place of employment, achievements for which the applicant has received the Prize;

2.7.2. terms and procedure for awarding the Prize;

2.7.3. terms and procedure for posting the information about the Competition results on the RUDN University website;

2.7.4. departments and employees of RUDN University (with contact details indicated) responsible for organizing the award of the Prize, payment of honorarium and posting the information about the Competition results on the RUDN University website.

2.8 The Competition shall be considered invalid if there are nominations of less than ten three Applicants or if there are no worthy candidates among the Applicants by decision of the Commission.

3. Procedure for Nominating for the Prize

3.1 The following have the right to nominate Prize Applicants (no more than one):

3.1.1. councils of scientific/scientific and educational organizations engaged in research activities in the field of mathematics;

3.1.2. foreign scientific and educational organizations;

3.1.3. academicians and corresponding members of the Russian Academy of Sciences;

3.1.4. members of International Research Boards of RUDN University;

3.1.5. laureates of state and international scientific awards;

3.1.6. members of foreign state academies and state or international research communities.

3.2. Self-nomination for the Prize is not allowed.

3.4. Works previously awarded the Prize of the Russian Academy of Sciences, State Awards of the Russian Federation, national, nominal state awards of other countries or international awards, as well as works, the authors and co-authors of which are affiliated with the RUDN University researchers are not accepted.

3.4 The Application shall include:

3.4.1. works or series of works in English (in electronic form) submitted for the Competition.

3.4.2. information about the Applicant (Appendix No. 1) with copies of documents which prove the Applicant's identity³ and confirm the Applicant's qualifications and scientific achievements;

3.4.3. Nomination of the Applicant by persons or organizations (Clause 3.1) indicating the research / scientific and technical significance of the Applicant's work (Appendix No. 2);

3.4.4. documents confirming the authority of the nominating person or organization⁴;

3.4.5. Applicant's consent⁵ to personal data processing (Appendix No. 3, Appendix No. 4)

3.5. Applications shall be submitted to RUDN University in the manner established by the Order on Announcing the Competition. Applications received for the Competition will not be returned. Applications received after the submission deadline will not be accepted for consideration.

3.6. The terms and procedure for submitting applications should be published on the RUDN University website in accordance with the deadlines specified in the Order announcing the Competition.

4.1 A Commission is established to review Applications submitted to the Competition, in order to ensure the objectivity of the evaluation of the submitted materials and award the Prize. The Commission is established for the period necessary to review the submitted applications, evaluate the submitted materials and determine the winners of the Competition.

4.2 The Commission shall be formed by the leading scientists in Mathematics nominated by the Academic Board of the Faculty of Science of RUDN University. The list of the Commission members shall be submitted for consideration by the RUDN University Academic Board and approved by the Order of RUDN University based on the decision of the RUDN University Academic Board.

4.3 The Commission shall consist of at least 10 people (including the chairman, first deputy and secretary), including:

4.3.1. leading specialists and scientists of RUDN University in Mathematics;

4.3.2. leading Russian and foreign scientists in Mathematics.

4.4. The number of members of the Commission may be increased after the completion of the acceptance of applications in the case of a significant predominance of applications from a particular field of mathematics in order to strengthen the Commission with specialists of the appropriate profile by decision of the Chairman. Changes to the list of Commission members are approved by the decision of the RUDN University Academic Board in accordance with the procedure specified in clause 4.2 of the Regulations.

At least 30% of the Commission members shall be foreign researchers.

4.5. The list of the Commission members is not published in open sources.

4.6. The Commission shall be guided by the norms of research ethics in its work and excludes possible conflicts of interest.

4.7. A conflict of interest is considered to arise if a member of the Commission:

4.7.1. is connected with the Applicant by current or past research work, has joint publications, results of intellectual activity;

4.7.2. is or was in an academic supervisor – student / postgraduate student / degree seeker / academic advisor relationship with the Applicant;

4.7.3. is related to the Applicant;

4.7.4. is in a contractual (financial) relationship with the Applicant;
4.7.5. initiates the nomination of the Applicant for the Prize (see Clause 3.1) being a member of the International Research Board of RUDN University.

4.8. The Chairman of the Commission shall arrange for the members of the Commission to familiarize themselves with the text of these Regulations. A member of the Commission shall independently notify the Chairman and other members of the Commission of a conflict of interest in the cases specified in Clause 4.7 and shall be excluded from participating in the discussion of the submitted applications within the framework of the current year's Competition and voting. If the Chairman of the Commission has a conflict of interest, his powers shall be transferred to the first Deputy Chairman.

4.9. If the number of Commission members who have declared a conflict of interest exceeds 3 people inclusive, the issue of changing the list of the Commission members for the current year's Competition shall be submitted for consideration to the RUDN University Academic Board in accordance with the procedure specified in clause 4.2 of the Regulation.

5.1 The first meeting of the Commission shall be held no later than 2 weeks from the date of completing the submission of Applications for the Competition. A list of Applications which meet the formal requirements of the Competition and the presence of a conflict of interest among members of the Commission shall be determined at the first meeting of the Commission.

5.2 The Commission shall make a decision on nominating the Applicant for the Competition Prize and preparing a proposal to approve the winner based on the consideration of all submitted Applications and materials on them. The decision shall be made by a simple majority of votes of the Commission members. In the case of an equal number of votes, the vote of the Chairman of the Commission or the Acting Chairman (see Clause 4.7) is casting. A quorum is recognized as present if there are votes of at least 2/3 of the Commission members.

5.3 The Commission's decision is formalized by a protocol signed by Chairman of the Commission. The decision of the Commission with the relevant materials shall be sent for consideration by the RUDN University Academic Board in the manner established by RUDN University. The materials shall include:

- 5.3.1. information about all submitted applications and the Applicants;
- 5.4.2. proposal to approve the Competition winner with justification.

6. Issuance of a Duplicate Badge and Badge Certificate

If the badge and the badge certificate are lost (damaged) as a result of a natural disaster or other emergency circumstances, the awarded person may be issued duplicates by decision of the RUDN University Academic Board.

A request for the issuance of a duplicate badge and a duplicate badge certificate to the awarded person is initiated upon the application of the awarded person by decision of the Academic Board of the Faculty of Science of RUDN University after checking the circumstances of the loss and submitting supporting documents.

6.2. In other circumstances of the loss of the badge and badge certificate, the awarded person is given a certified extract from the RUDN University Order on awarding the Prize.
